E-Responder Program

The E-responder Program is an electronic way of gaining new members. Any US Citizen 17 years of age or older can go online and request information regarding membership in the USCG Auxiliary.

The information received by the National Website is then sent to the closest District where the individual lives. Upon receipt by the District, the individual is contacted and the recruiting process begins by the various Personnel Services Officers. The individual is qualified (US Citizen and 17 years of age) by the SO-PS and then forward to the Flotilla closest to the E-responder’s area. It is then up to the FSO-PS, acting as the salesman for the Auxiliary, to explain “what we do” and answer any questions the individual may have.



# ***The SO-PS Team***

## ***Division 01***

The island of Puerto Rico is located about 900 NM South-East of Florida. Division 1 consists of 9 flotillas located on the North, South, East and West coasts of the Island. The 9 Flotillas are: 11 Fajardo, 12 Cangrejos, 13 Ponce, 15 Dorado, 16 Mayagüez, 17 Aguadilla, 18 Cabo Rojo, 1-10 San Juan, 1-12 Santurce. Division 1 has 367 members.

Coast Guard Air Station Borinquen is located on the North-West Corner of the island. The primary mission of Coast Guard Air Station Borinquen is search and rescue. Sector San Juan is responsible for all Coast Guard missions in the Eastern Caribbean area. Sector San Juan includes the Captain of the Port and Officer in Charge, Marine Inspection zones which are comprised of both the Commonwealth of Puerto Rico and the Territory of the U.S. Virgin Islands and the adjacent waters to the outermost extent of the EEZ. Sector San Juan is also designated a Rescue Sub-Center and is responsible for Search and Rescue Operations for the Eastern Caribbean Sea area east of and including the Dominican Republic and the Lesser Antilles islands chain.

## ***Division 02***

Division 2 is comprised of “inland flotillas” with units on most of the major lakes in Georgia and SC. We are comprised of the following flotillas: 21 Augusta, 22 Lake Altoona, 25 Lake Hartwell, 28 Central Georgia, 29 Lake Lanier, Northeast Georgia (Consolidation of 24 and 26)

## ***Division 03***

# ***Division 04***

Division 4 consists of 8 Flotillas: 42 Palm Bay; 46 Cocoa; 49 Titusville; 48 New Smyrna; 44 Daytona Beach; 4-11 Orlando area and 43 Tavares. Flotillas 42, 46, 49, 48 and 44 patrol areas that are located in the Intracoastal Waterway; Flotilla 4-11 is responsible for the lakes and waterways around the Orlando/Kissimmee Chain of Lakes. Flotilla 45's area is the St Johns River from Sanford north to Lake George. Flotilla 43's area is the Chain of Lakes around Tavares consisting of 4 lakes.

All Flotillas support the Coast Guard and Kennedy Space center during Shuttle and Rocket launches by way of establishing picket lines to prevent recreational boaters from entering into danger zones. # ***Division 05***

Division 5 is made up of 7 Flotillas which serve the Treasure and Gold Coasts of southern Florida. The Division's Area of Responsibility extends from Delray Boynton Beach, in the south, to Vero Beach in the north. There is also a Flotilla in Lake Okeechobee. Division 5 has close to 400 members who donate thousands of hours in support of Coast Guard missions. # ***Division 06***

Division 6 is located in a very unique geographic area, Not only is our Station (Miami Beach) co-located on the same small island as Sector Miami, but, Miami is also home of the 7th District Command and Air Station Miami. All TCT training here is done by the Auxiliary, which includes Station, Sector and District. We also train and help qualify Coast Guardsmen at the Station, as watch standers, Boarding officers are trained by Auxiliarists at the Armory and our Command Centers also require their members to learn basic boating safety from the Auxiliary. In addition to training, we also routinely perform the duty of standing watch at Station radio, Sector's Hawkeye, the Ships arrival's desk, Sector Clinic. Auxiliarists also work for Sector Water Ways Management, Planning and in the Directors Office. We're blessed with beautiful Biscayne Bay and a rather large variety of ways local boaters can get into trouble. Our multi-mission patrol boats perform their missions on Biscayne Bay every weekend and especially Saturday nights. Our aircraft fly every day and often several times a day.

One of the recruiting areas we're very proud of is our Division Prospective Members Orientation meetings. Over the past several years, we've developed a two hour training session, usually with a large group of prospective members and representatives from each Flotilla. The program covers a PP presentation explaining the duties and responsibilities of Auxiliarists, the Auxiliary structure, the various educational courses offered, location of our Flotillas and a Q&A period. The date for a follow up meeting is announced for those who wish to commit, new member information is then passed out including instructions on what will be needed for that meeting.

Division 10 is located along the very southern South Carolina coast and the entire Georgia coast. We have 4 flotillas in our Division. They are 10-1 in Beaufort, SC; 10-2 in Savannah; GA, 10-10 in Brunswick, GA and 10-11 in Hilton Head, SC. We all operate under Sector Charleston, SC, including the local USCG units. Our Flotilla Staff Officers for Personnel Services are: 10-1, Don Becker; 10-2, Ted Phillips; 10-10, Linda Clavin; 10-11, Karen Wilson.

We are fortunate in this area to have several USCG units. There are boat stations at both Brunswick, GA, and at Tybee Island (Savannah), GA, co-located at Tybee is ANT Savannah. Additionally, there is a USCG Air Station in Savannah located on Hunter Army Air Field that flies the HH-65 Dolphin helicopter and the Marine Safety Unit located downtown Savannah in one of the Federal Buildings. Having these units gives us opportunities to serve the Coast Guard in several capacities. There are Auxiliarists working at each of the units in various positions.

In addition to performing our regular patrols, we do patrols for the Marine Safety Unit, boating along the commercial piers on the Savannah River logging data about the various vessels docked there. On Mondays and Thursday, the flotillas take turns doing Helo-ops for the Air Station, acting as distressed vessels for the aircrews to practice basket drops, swimmer deployments, etc. Some of our members work with the ANT keeping records and performing repairs along the local waterways. We are in an active Coast Guard area and have an active Auxiliary Division. We are very proud of this and really enjoy being a part of a great team.

## ***Division 11***

Division 11 is located along the Gulf of Mexico on the West coast of Florida and is comprised of Flotillas 11-1 Clearwater; 11-10 Dunedin; 11-9 Tarpon Springs; 11-6 New Port Richey and 11-7 in Hudson. The Division is very tight knit with all of the flotillas interacting in public education, member training, vessel examinations, surface operations, and public affairs. Our CG Station is Sand Key which hosts our Division-wide Operational Excellence weekends and assist in our ISAR training.

Our Division is relatively small with just under 300 members, but what it lacks in size is made up for in dedication and a total team atmosphere and effort. Neighboring Charleston-area flotillas have volunteered formal training and mentoring that is paying off with substantial PE and OP growth. With new detachments established on Lake Marion (12-3) and another precedent-setting one at the S. C. Military University (12-8), The Citadel, we're expecting even more growth this year.

## ***Division 14***

Division 14's AOR extends from Fernandina to Palm Coast and from Jacksonville to Palatka. In addition to the Atlantic seaboard and the Intracoastal Waterway, our Division is also responsible for about 60 miles of the lower St. Johns River, through Jacksonville, a very busy and important seaport. Our seven Flotillas work very well together in support of Sector Jacksonville and Station Mayport in such areas as radio watch standing, Coast Guard licensing document investigator, area disaster center planning, and harbor patrols. Currently, about 12 members are being trained by Station Mayport to work on vessels supporting helicopter training evolutions.

On Tuesday, Feb. 12, a large ship carrying cranes to be unloaded, mounted and used for loading and unloading containerized cargo made its way up the Savannah River after a voyage from China. The ship was escorted by the Coast Guard and CG Auxiliary up the river and under the Tallmadge Bridge. The trip was planned so that the ship with the cranes passed under the bridge at dead low tide. The estimate was that there would



be 8 feet of clearance between the top of the cranes and the bottom of the bridge. The speed of the ship was approximately 1.5 knots for the passage.

The Auxiliary has been providing pickets for a security zone around the ship while the cranes have been unloaded on several occasions during the last week and a half

# ***USCG/Aux Assist in Sugar Cane Explosion***

On the evening of Feb. 7 at about 7:15 PM there was an explosion at the Dixie Crystal (owned by Imperial Sugar) refinery on the Savannah River. The initial death toll of 6 has climbed to 10 as 4 of the employees who were critically injured have succumbed to their injuries. At one count there were 40 employees injured. The cause of the explosion was found to be fine sugar dust. The source of the ignition has not been determined and is still under investigation.

One of the members of Flotilla 10-2, who is qualified in HAZMAT, and who has been working with the Savannah MSU was called to accompany an MST3 from the MSU to investigate the presence of Mercury (used in instrumentation) at the sight of the pollution booms were set in place on the river around the refinery docks.

Coast Guard Station Tybee and ANT Tybee provided several boats and Coast Guard Air Station Savannah provided a helicopter for SAR and to check for any pollutants in the River. No one was found to have been in the river and there was little or no pollution from the incident.

Flotilla 10-11 was able to provide a facility on-scene at approximately 11 pm and it remained on the scene until 4 am. The next day at first light 3 USCG/Aux vessels from Flotilla 10-02 (Savannah) and one vessel from Flotilla 10-11 (Hilton Head) performed picket duty for the security zone established around the area. One other facility was on standby in case they were needed later that evening but were released without being used.



# ***Helo Hoist Training***

During the Recruiting process, PS Officers are called upon to brief New Member Prospects on the many opportunities which exist for providing volunteer assistance to the U.S. Coast Guard. One such opportunity for our Auxiliary Members is Helo Hoist training for search and rescue missions. More and more D -7 Auxiliary Members are working with their Air Station personnel to gain Helicopter Hoist training and certification. Since Search and Rescue Missions frequently require helicopter evacuation of sick, injured or stranded mariners, those Coasties and Auxiliarists answering the SAR calls are better equipped to provide assistance if they have had qualification training in HELO Hoist operations.

Don Mooers, a Division 14 FSO-PS officer (and past DSO-PS 7), recently went through (PNACO) to HELO Hoist Training at Hilton

Head Island under Division 10 Mentor Henry Pratt to become certified by CG Air Station Savannah in HELO Hoist. Don put his certification to work last month demonstrating for new Coasties aboard a USCG 47 ft. fast boat various hoist techniques. The following photos of that training show Don and another Flotilla 14-04 Aux Member ready to take in the hoist basket; Don being loaded into the hoist basket by Coasties; being hoisted up to the Dolphin "chopper"; and Don returning safely from the Dolphin HH-65 to the 47 ft. CG vessel all while underway at about 10 knots.

3. Submit 2 fingerprint cards (black ink preferred)
4. Submit the new member exam sheet
5. Submit a copy of the Boating Safety Course Certificate if previously taken
6. Submit one photo of the new prospective member either as a photo print or CD. Include the name of the individual and Flotilla on the rear of the photo or CD. A floppy is not recommended.
7. Submit a copy of the document used to verify citizenship.

**SUBMISSION OF THE 7001:** ALL new member packages must be submitted to DirAux West via the DDSL or ADDSL

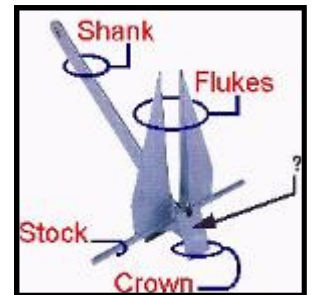

7. **Barcelona Lighthouse**  
**Barcelona, NY**

Barcelona Light is presently a very good- looking private residence with an inactive light tower attached. The grounds are not open to the public, but are easily viewed from NY-5 (the Seaway Trail).



This 40-foot tower of natural fieldstone was constructed in 1829 in response to increased shipping traffic after the opening of the Erie Canal. It was de-activated in 1859. The light had a very innovative fuel system, consisting of a wooden pipeline running from a nearby pocket of natural gas, burning 11 lamps with 14-inch reflectors. The lighthouse thus became the first public building in the US lit by natural gas. To this day there is a gas street light shining from the tower.
